## DRIVER'S LICENSE or ID REQUIREMENT Illinois is Now Requiring to efile!



A handful of states are now requiring a valid taxpayers driver's license(s) or ID number to e-file a tax return. This is an additional security measure to confirm a taxpayer's identity and eventually other states will follow.

## Options to Provide SS+G with Driver's License or ID Information

A Photo Copy is preferred so we can properly confirm the information.

- 1. Secure Link NO DROPBOX ACCOUNT IS REQUIRED
  - o The easiest way to provide SSG a photo copy electronically is to use the upload link below.
    - LINK TO EASILY UPLOAD DRIVERS LICENSE PHOTO
    - ii. Click "Add Files"
      - If photo previously was taken, Click Add photo and select from your "photos"
      - If photo has NOT yet been taken, Click "Take Photo or Video" & Take a cell phone photo of driver's license or ID
      - Browse will allow you to upload from any other source (Dropbox, iCloud, G-drive)
    - iii. Type in your Name & Email Address in the 2 textboxes provided.
    - iv. Click "Upload" and SSG will receive photo secure & encrypted insuring security.
    - v. Client will receive a confirmation email that the files were successfully uploaded.
- 2. Client Organizer
  - o Write/type in your information in the mailed paper copy or electronic Client Organizer.
  - o Located on "Personal Information" Page in the Tax Organizer.
  - o Please remember to fill in this information before returning back to SSG.
- 3. Shared Dropbox folder Place copy in our shared Dropbox Folder
  - o If you have a Dropbox account place a copy along with all other files in our shareable folder.
  - o Place in 2020 NOT YET FILED > FILES
- 4. Personal Dropbox Upload Link NO DROPBOX ACCOUNT IS REQUIRED
  - o Every client has a secure encrypted personal upload link to our shared Dropbox.
  - o This link can be located in email sent to client when 2019 tax return electronic copies were completed. Or Email <a href="mailto:img@ssgltd.com">img@ssgltd.com</a> to be directly forwarded your personal upload link.
  - Files uploaded via your personal upload link are placed in folder with below filepath...
